June 1944 to April 1945: (In June 1944 I resigned from the National CIO War Relief Committee expecting to enter the U.S. Navy. This did not happen but my draft status remained uncertain and permanent employment was impossible. For a period of about ten months there were the temporary jobs below involving fund raising and public relations:)

- National Citizens Political Action Committee, assistant finance director. This was actually an adjunct to the CIO Political Action Committee, in the fall of 1944. Worked for Nelson Bengston.
- Union for Democratic Action, ass't. to the Director. A social action agency whose chairman was Reinhold Niebuhr. Worked for James Loeb.
- India League of America, an agency concerned with freedom for India. Worked for J. J. Singh.

May 1942 to June 1944: Assistant National Director, CIO War Relief Committee. At the beginning of the Second World War the AF of L and CIO had planned to develop their own war relief program separate and apart from the War Chest and the Red Cross Program. Early in this development I had raised some questions about this procedure with Monroe Sweetland, the National Director of the CIO War Relief Committee. Shortly thereafter, Mr. Sweetland asked me to join the staff of this agency to work out relationships with the National War Fund and the American Red Cross which would result in an effective program of labor participation in the activities of these agencies. The result was an extensive program of participation in the War Relief activities of these agencies which eventually resulted in a staff of nearly one hundred in over 20 regional offices and the raising of several millions of dollars through labor participation. The present CIO Community Services Committee is an agency which resulted from the activities of the CIO War Relief Committee. Mr. Sweetland joined the staff of the Red Cross in 1943 and was replaced by Mr. Leo Perlis.

September 1941 to May 1942: Director-Division of Service to Labor Detroit Council of Social Agencies. The problems of integrating the new community leadership which was developing through the organized labor movement had been recognized for some time. The Division of Service to Labor was an effort to help social agencies become oriented to this new factor in the community and to help labor leadership become integrated with the leadership of social agencies. The concerns of this department also included the special problems of minority groups. Little was actually accomplished because I left the position too soon.

September 1940 to September 1941: Assistant Director of Community Councils, Detroit Council of Social Agencies. Helped organize a Community Council program in Detroit, Michigan; worked with neighborhood groups, church, civic, and social. In addition, worked with some city wide housing and youth activities in an advisory way. Prepared bulletins, conferences, social work interpretation.

Spring of 1940 to September 1940: Special Assistant, Buffalo Council of Social Agencies, Genesee Building, Buffalo, New York. General Assistant to Director of the Buffalo Council; helped with recreation study and housing study and made a study of treatment of alcoholics.

June 1939 to Spring of 1940: Tenant Selection Aid, Buffalo Municipal Housing Authority, Buffalo, New York. Investigator for applications for units in newly completed housing projects.

Summary: My work experience has involved the following major areas: Race relations and intergroup relations; Community organization for Health and Welfare services and planning; Community organization administration; Education and interpretations housing and city planning; labor relations.

General Summary: My general interest has been with the relatedness between people, problems, ideas, movements and planning. Race Relations problems are an integral part of many other kinds of problems. The ways in which tension is handled in any given situation is related to how the situation is understood and hence interpretation is important. Housing and city planning and welfare planning is interesting because in these designs we reveal our intentions about the way we think the world ought to be. Administration in these areas has always interested me because at its best it is a synthesis of all of these factors in a realistic and practical way.
